II. SYNCING YOUR DATA WITH Distribution Market Advantage, Inc.

1. Join a GDSN data pool such as Syndigo. Please contact Syndigo via <https://syndigo.com/distribution-market-advantage> to get more information.
2. DMA has already set up a GDSN subscription for you based on your registered Information Provider GLN.
3. Publish your full product catalog (both existing and available to purchase items) to:
 - Distribution Market Advantage, Inc. GLN 0865761000108
4. Suppliers **MUST** maintain their items using GDSN data synchronization.

III. CIC RESPONSE MESSAGES

- “Review” – DMA has found a GTIN match in their Enterprise Data system, however DMA has not synchronized your item for any of the reasons listed in the CIC message. The CIC message will include *Status Details* information explaining the issue for that GTIN. If the data provider believes information published was correct, please contact <https://syndigo.com/support>
- “Synchronized” – DMA has found a GTIN match in our Enterprise Data system. The item passed all DMA validations and has been ingested into DMA’s systems.
- “Received” – A received CIC will automatically be sent when the publication is received by DMA and is passing all validations however it has not yet been ingested into the DMA Systems.

- Please include all relevant Diet Types

- Please include County of Origin information

- Please include at least 1 image for each product
- Types of images that requested
 - Main Product Image
 - In the Package View
 - Prepared Image
 - Raw/Uncooked Image
 - Plated Image
 - Nutrition Facts Label Image
