

Welcome to View My Product for Subway!

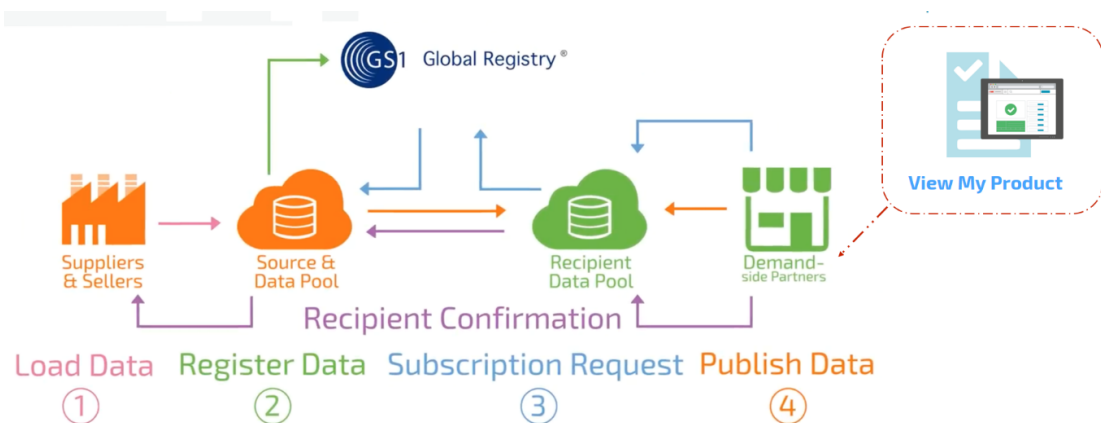
Whether you are new to View My Product or have logged in before, please take some time to review this quick guide to ensure you are compliant with Subway's product information needs. There are 4 simple activities that you will need to focus on:

- Achieve 100% GS1 Completeness score
- Achieve 100% attribute accuracy score
- Update product information by working with your GS1 Certified Data Pool
- Improve your product descriptions by using product specific 'Attribytes'

How does it work?

View My Product is a complement to the work you are doing with GS1, not a replacement. By logging into Attribytes, you will see exactly what is in Subway's internal systems, not just what has been published through the Global Data Synchronization Network (GDSN). This allows you to:

- See how GS1 information has been consumed by Subway
- Download your compliance scorecard
- Download lists of active items & GTIN accuracy
- Review the discrepancies between your GDSN data and Subway's physical attribute audit



NOTE: All updated product data should be provided through Global Data Synchronization Network (GDSN) by working with your GS1 Certified Data Pool. While View My Product allows you to view product information that has been received by Subway, all item updates are to be provided through the GDSN!

What do I need to do to be compliant?

There are two major aspects of your GS1 compliance with Subway:

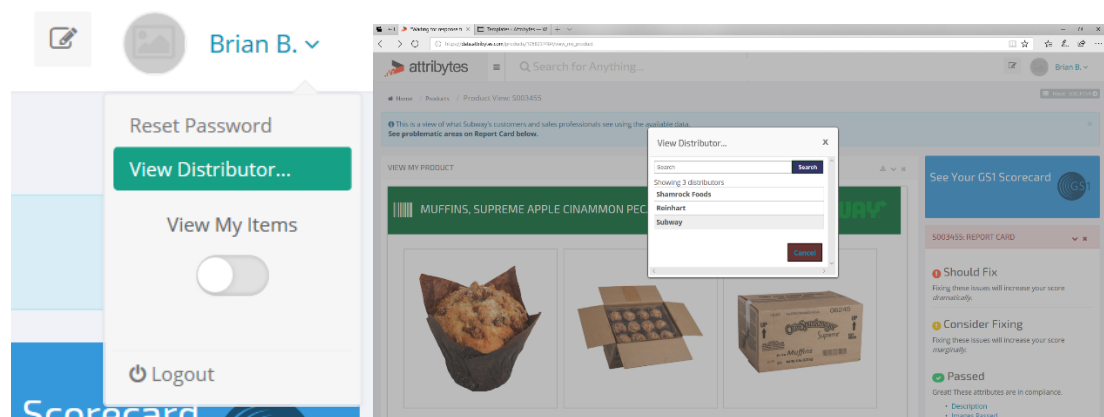
GS1 Completeness – This means you have published all required GDSN data for Phase I and Phase II Data. This includes all images, marketing, nutrient, and allergen information. For a complete listing of required attributes, you can download the IPC/Subway GDSN Implementation Guide by going to www.attribytes.com/SubwayHelp.

Data Accuracy – Subway periodically performs physical cubiscan audits on your products. These physical audit fields are then compared to the data in Subway's Internal System as well as what has been published. Discrepancies must be resolved by publishing GDSN data to match or fall within the expected tolerance. Let's get started!

First, go to www.attribytes.com/SignupSubway to receive new credentials or to have Subway added to your existing profile.


You may filter on Subway's list of products by clicking on your name in the top right of the screen and selecting 'View Distributor...'




1. See how GS1 information has been consumed by Subway














You will see a rendering of all the product information that Subway has stored in their internal systems on your products. You may navigate to different products in 3 ways:

- Click on the 'Next:' button at the top right
- Click on the eyeball icon within the list of products being displayed
- Search for a product code or GTIN in the 'Search Anything' box.





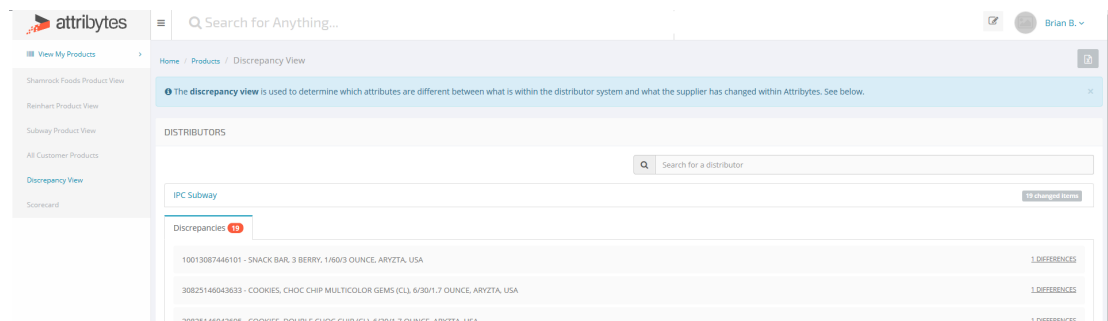

Note: Items that are considered 'Not Accurate' can be viewed by going to the 'Discrepancy View' from the fly-out menu

4. Review the discrepancies between your GDSN data and Subway's physical attribute audit

This is where you can see items that have differences between what is listed in Subway's System, the physical cubiscan audit, and your GDSN publication.



You can then see what the discrepancies are by clicking on the 'differences' link to expand the view.



Completing the product specific Attribytes

Product Attribytes are specific attributes that help ensure products are properly categorized and to improve product descriptions. When in the product view, you can expand the item to see which drop downs need to be completed.
